CODE GB-MED

Manufacturers Association indotributerjev medical devices GB-MED, at its 3rd meeting of 05.27.2014, adopted CODE OF ETHICS.

The Association of Slovenian producers and distributors medical technical aids Slovenia

Article 1

Members of the Association of Slovenian producers and distributors of medical technical aids Slovenia will take into account in their work and practice its constitutional principles, law and all binding secondary legislation governing the area of our operations.

2. Article

Members of the Association shall commit ourselves in our work to respect professional ethics of other professions and all the rules governing their operation, particularly provisions of the Code of medical ethics of Slovenia and the Code of ethics of nurses and medical technicians Slovenia, and the code of ethics of the European association Eucomed, and we do not They acted contrary to their principles.

3. Article

In particular, we commit ourselves to respect the law, aimed at strengthening the integrity and transparency and prevent corruption and prevent and eliminate conflicts of interest.

In doing so, we will strive to prevent and eliminate risks to members and all those involved with the business, its powers, responsibilities or powers used in contravention of the law, legally permissible objectives and codes of ethics. We will do its best to prevent breach of duty of official and responsible persons in the public or private sectors, as well as the behavior of persons who are the initiators of the offense or persons who can avail themselves of the infringement, which directly or indirectly promised, offered or given or requested, accepted or the expected benefits for himself or for another.

4. Article

Association members expressly agree that the contract in which someone in the name of or on behalf of the other party, representative or agent of the authority or public sector organizations promises, offers or gives any undue advantage for:

- the acquisition transaction, or
- to conclude business under more favorable conditions, or
- for the omission of due supervision over the implementation of contractual obligations or
- for other act or omission by which authority or organization from the public sector damage caused or enabled an undue advantage to the representative body, authority or intermediary organization from the public sector, the other party or its representative, agent, broker, zero.
